Permitted display periods:

- Grand Opening sign(s) are allowed for 60 days (one-time only).
- Other temporary sign(s), including a feather flag, are allowed 7 days at a time, 3 times a year.
- A feather flag may be displayed only during business operating hours.

Permitted location:

- Generally, temporary sign(s) must be located on private property.
- A feather flag for commercial property along Sebastian Boulevard may be located within that portion of the right-of-way between the sidewalk and the business property line. If so located, the disclaimer above must be signed.

## (e) Temporary Sign Regulations

- (1) Grand opening signs
- May not be installed before C/O
  - Allowed for 60 days
  - Properties < 100 feet frontage allowed 32 SF
  - Properties = or > 100 feet frontage allowed 64 SF
  - Banners and portable signs may be used
- .....
- (6) Other temporary signs
- a. • Properties < 100 feet frontage allowed 32 SF
  - b. • Properties = or > 100 feet frontage allowed 64 SF
  - c. • Permitted up to seven days at a time and up to three times in a calendar year
  - d. • Banners and portable signs may be used
  - e. • Feather flags permitted to be used as other temporary sign, with time limitation listed in c. above
    - i. • Excludes city-owned IN & AI
    - ii. • Needs permit
      - One per business
      - Non-transferable
      - No fee
    - iii. • Permit application to include sketch with:
      - Dimensions
      - Copy area
      - Materials
      - Location
      - Must be approved before sign is displayed.
    - iv. • Maximum height 12 feet
    - v. • Not illuminated
      - No attachment of moving parts, balloons, streamers, pennants, etc.
      - Cannot be attached to structures, poles, objects, or other signs
      - Display only during business operating hours
    - vi. • Display in accordance with 54-3-16.5(b)(5)f, Location of Sandwich Board Signs
    - vii. • Feather flags in violation will be removed & privileges denied for remainder of year
    - viii. • Other agencies may have additional restrictions
